## Scope of work for OLTC Testing and Servicing:-

Easun-MR Scope of Work (for Overhauling):

1. The vendor shall bring all necessary tools with a full packed toolkit for overhauling
2. Lifting of diverter switch insert from the oil compartment.
3. Dismantling of the diverter switch at site.
4. Cleaning & Inspection of contacts and all the insulating parts.
5. Measurement of Transition resistance with Multi meter.
6. Measurement of Contact wears and furnish the same in EMR check list sheet.
7. Inspection of Braid, Tightness and healthiness of insulation components.
8. Cleaning with fresh oil
9. Re assembly of diverter switch.
10. Inspection and Cleaning of diverter switch oil compartment.
11. Cleaning & inspection of Drive mechanism.
12. Greasing of Top Drive Unit & Bevel Gear.
13. Check the coupling components of all the poles.
14. Inspection of Protective relay, Bevel Gear & its shaft assembly.
15. Checks raise and lower operations of all taps.
16. Performing operating tests and re-commissioning.
17. Perform Dynamic Contact Resistance Measurement (DCRM) test to measure the below parameters in OLTC before & after overhauling.
18. The vendor shall submit detailed analysis report after 2 days of its test completion at site. The report shall include but not limited to the following,
  - a. Operation timing of Diverter switch
  - b. Timing of Selector switch operation
  - c. Motor load current during operation
  - d. Duration of Transition resistances in diverter operation
  - e. Synchronization between Diverter & Selector switch
  - f. Three phase synchronization
  - g. Obstructions or Tightness in operation
  - h. Looseness in OLTC contact points
  - i. Spring tension of selector & Diverter contacts
  - j. Deformation of Diverter contacts, if any
19. Based on the satisfactory results of DCRM, transformer will be re-commissioned, OLTC shall be operated in trial run at full load.
20. Voltage ratio test shall also be carried out before and after servicing of OLTC.

### **RCF's Scope:**

1. RCF shall provide crane and Filtration Machine at site.
2. RCF to provide Fresh transformer oil at site.
3. Unskilled or semi-skilled manpower shall be provided by RCF at site.
4. All Spares if required to be replaced during Overhauling/servicing/rectification shall be provided by RCF at site.

5. General purpose tools and tackles required for carrying out the work will be provided by RCF free of charge. Any special tools required for the replacement of the TPI assembly shall be arranged by the party.
6. RCF shall provide the 3ph, 415VAC supply required for the testing and execution of the complete job.

**Note:**

TWO mobilizations of Three days each are considered for one transformer. Travelling period of 2 x 4 days for each transformer is considered.

**Tenure of contract:** Tenure of contract shall be **One Year** from the date of issue of work order

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1

bidders through a Random Algorithm executed by GeM system.

16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
