3. **2. Buyer Added Bid Specific Scope Of Work(SOW)**

**SCOPE OF WORK**

- (a) The party shall service the lifts thoroughly including oiling, greasing, cleaning the machine, motors and other components, adjusting all mechanical parts & other controls if necessary, relays, especially safety devices & submit the reports in time, once in a month.

- (b) Checking of all interlocks, door switches, level switches, safety interlocks etc . during monthly service for smooth operation of lifts.
- (c) Fulfilment of all obligations under Laws governed by I.E. & L. department of Govt. of India & of Maharashtra state.
- (d) The Contractors service men will attend to the lifts when called upon during normal working hours. In case of emergency, they will work 24 hours on round the clock basis if required. Normally a call is required to be attended within 24 hrs.

If the contractor fails to attend breakdown call within 24 hours, a penalty of a week's payment deduction (for delay more than 24 hrs. and less than 7 days from intimation time) shall be imposed. For a delay more than a week, entire monthly payment shall be deducted. However, if the Engineer-In-Charge is satisfied that the breakdown job needed more time to attend, then no penalty shall be levied.

- (e) It will be responsibility to the Contractor to ensure that the lifts are available for service all the time except for shut down taken for service/repairs.
- (f) All the lifts shall be checked for operation and any abnormality as and when asked, this frequency shall not be more than once a week depending on lift performance. And if any problem is noticed the same shall be immediately attended.

#### **REPAIRS:**

The Contractor will repair/replace all the spare parts and/or overhaul the lifts or parts/spares, free of charge with need repair/replacement.

#### **PARTS REPLACEMENT:**

All the parts that constitute the lift system as mentioned or not mentioned below shall be covered under the Comprehensive AMC Contract.

1. Cage and accessories inside and on cage inside the shaft (guide rails for car and counter weight, pit buffer, safety mechanisms etc.).
2. Ropes and flexible traveling cables.
3. All machine room equipment, motor, traction shoe, counter weights, all pulleys, gear box, etc.

4. Overload device, ARD Panel and Battery Bank
5. Doors, light and fans are excluded.
6. Control panel (main) and all the switches, relays, contractors, wiring, indicators, push buttons and other accessories and interlocks of the control system.
7. It will be responsibility of the Contractor to ensure and satisfy, all the statutory requirements spelled by the Lift Inspector and other statutory bodies. Inspection and other statutory fees shall be paid by RCF on submission of invoice / letter / receipt from the appropriate authority.
8. The contractor shall ensure that the lifts are inspected by the statutory body once every year.

### **SERVICING:**

The Contractor will regularly examine, adjust and test all the operation of lift, all the safety and interlocking device, check and lubricate moving parts, and carry out preventive maintenance once in a month.

### **OTHER TERMS AND CONDITIONS:**

- i. Summary of visits shall be furnished with the bills.
- ii. Routine monthly servicing shall be done before 10<sup>th</sup> of every month.
- iii. Report on examination of lifts shall be submitted on yearly basis.
- iv. Whenever there is a visit of VIPs, party shall arrange to depute a technician on VIP personal visit day as per intimation by RCF Engineer.

**Tenure of contract:** Tenure of contract shall be **TWO YEARS** from the date of issue of work order.

### **अस्वीकरण/Disclaimer**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any

Category item bunched with it.

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.**
