Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

SCOPE OF WORK

1. SCOPE:

- Scope includes digitalization of power and control drawings for 100 kV, 11 kV, 3.3 kV switchboards and 415V MCCs.
- Vendor shall convert existing hard copies into intelligent digital format using professional ECAD software such as AutoCAD Electrical, EPLAN, or equivalent.
- All digitalization work shall be carried out at RCF premises only.
- The vendor shall depute the required manpower within 15 days from the date of intimation by RCF / HWP-Thal for timely completion of the work.
- The vendor shall mobilize with all necessary hardware and software required for the project, including laptops / PCs.
- The deputed manpower shall be experienced in preparation of electrical drawings using AutoCAD Electrical, EPLAN, or equivalent software in which drawings will be prepared by vendor.

- For each drawing, the vendor shall transcribe and embed all technical data such as motor nameplate details, cable details, breaker ratings, transformer details, etc. (Required data shall be provided by RCF). These are to be included in the drawing attributes
- The vendor shall maintain one-to-one mapping with existing sheet numbers and standard title blocks.
- The vendor shall ensure compliance with IEC / IS standards and maintain consistent layer conventions throughout the drawings.
- The vendor shall integrate a symbol-linked database for contacts, coils, and terminals.
- HT drawings: 100KV, 11KV & 3.3KV drawings, LT Drawings: 415V drawings.
- All drawings shall match the original schematics in logic and connectivity, or as instructed by the RCF Engineer.
- The vendor shall submit one hard copy of each drawing for verification purposes, along with a soft copy in PDF format.
- The vendor shall prepare and submit the drawings in editable soft format on a 512GB SSD hard drive after successful verification.
- The vendor shall also provide and install licensed software for viewing and editing of drawings on RCF PC / laptop, the software validity must be 1 year.
- After successful verification, the vendor shall submit two hard copies of the drawings for each switchboard, properly arranged in different file folders.
- The vendor shall submit hard copies in the original drawing sizes, i.e., A3, A4, A1, and A2.
- After successful verification, if any modifications are required in the drawings, the soft copy shall be sent to the vendor by email along with the required corrections. The vendor shall carry out the necessary changes and resubmit the drawings for verification. After final approval, the vendor shall submit two hard copies in the original drawing sizes, i.e., A3, A4, A1, and A2.
- Any new drawing required after the first four (04) months shall be communicated to the vendor by email with the necessary soft copy. The vendor shall prepare the new drawing and submit it for verification. After successful verification, the vendor shall submit two hard copies in the original drawing sizes, i.e., A3, A4, A1, and A2.
- Payment shall be made as per actuals.
- The vendor must ensure that all files are editable with no locked layers or blocks. All the nameplate and bearing data must be entered as "Attributes" or "Properties" within the software.

2. Completion Time:

Vendor shall complete all drawings provided for digitization within 4 months of intimation date. Job will be considered completed after successful verification of digitized drawings, submission of drawings in both hard & soft format and training to RCF engineers.

3. Warranty Clause:

The vendor shall be responsible for correctness and quality of drawings if found incorrect during verification period. During this period, any discrepancies or required modifications shall be corrected at no additional cost.

4. TRAINING

- Vendor shall provide hands-on training for five (05) RCF engineers for five (05) days.
- Training shall include ECAD operations, editing, reporting, and revision control.
- Vendor shall provide training materials in soft copy (PDF format).
- No additional payment shall be made for the above training.
- Issue training certificates and attendance sheets

5. Mobilization

In case the vendor is required to leave the RCF premises before completion of the work due to reasons attributable to RCF, remobilization shall be permitted upon further intimation. The vendor shall report at site within 15 days from the date of such intimation.

Tenure of the Contract:-

The work order shall be valid for a period of **TWO years** from the date of issue of work order.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy

of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.

8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
