Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

1) Past work experience:

a) Vendor shall be an IBR approved boiler manufacturer and repairer / IBR approved pressure part manufacturer and repairer.

Vendor shall submit valid IBR certificates along with technical bid.

b) Vendor shall have in house facility for bending and swaging of tubes.

Vendor shall submit complete details of their works along with photographs of the above facilities.

c) Vendor shall have executed the job of

Manufacture and supply of a new boiler OR replacement of tubes (procurement, manufacture (bending and swaging), supply and replacement) fulfilling the following minimum requirement

The boiler should be a fired water tube boiler of minimum capacity 64 tons/hour and working pressure 80 kg/cm² in the last fifteen years ending the last day of month previous to the one in which this subject tender is floated/issued in reputed fertilizer/ petrochemical/oil and gas/ power plants/ process industries/ Research organizations.

Bidder shall submit copy of PO/WO issued by their client along with all related drawings/ specification sheets/ documents to confirm the capacity of new/retubed boiler. This PO/WO shall be issued and executed within last fifteen years ending the last day of month previous to the one in which this subject tender is floated/issued.

Also as a Proof of execution of submitted work order, bidder have to submit of the following:

(i) Completion Certificate issued by IBR/client in support of the above / Customer Acceptance Certificate OR

(ii) GeM CRAC (Consignee Receipt and Acceptance Certificate) document OR

(iii) (a) Tax Invoice for the said PO/WO being considered for PQ and

(b) Proof of receipt of payment like bank statement for the above referred tax invoice OR

(iv) Any other document indicating work completion

2) Average annual financial turnover during the last three years, ending 31st March of the previous financial year (i.e. FY 2022-23, 2023-24, 2024-25) should be at least Rs. 596.18 Lakhs.

In case the date of constitution/incorporation of the bidder is less than three years old, the average annual financial turnover in respect of the completed financial years after the date of constitution shall be taken into account. In this case, the financial turnover during last financial year/ the average financial turnover during preceding two financial years should be at least Rs. 596.18 Lakhs.

The net worth should not be negative in the balance sheet of last financial year (i.e. net worth should not be negative on 'The Relevant Date').

The Net worth of Bidder should have not eroded by more than 30% in the last three years, ending on 'The Relevant Date'. It means the net worth of last financial year should not be less than 70% compared to the 3rd last financial year.

The net worth in each of these years should not be negative

If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
